Appendix 1 - Response from Hampshire Highways

Thank you for raising the parking issues at Church Lane in Sway near Lymington.

Congestion at school start and finish times is a common issue. It is recognised that difficulties can be experienced for short periods on term time weekdays. In these situations, where drivers are making quick stops to drop off and collect children, parking regulations are often flouted as civil enforcement resources cannot be provided at a level to ensure compliance.

Please note there is often an expectation that new parking restrictions would be a quick/low cost measure, but this is not the case. The provision of any new or amendments to formal parking restrictions requires implementation of a legally enforceable Traffic Regulation Order (TRO), which is a relatively costly and lengthy process including formal consultations and advertisements. It is also a resource intensive process and the cost of the parking signs and road markings is usually minimal compared to the staff resources and legal costs involved.

Successive cuts to local government funding combined with increasing pressure on social care budgets has severely limited the County Council's ability to carry out detailed reviews of every site reported to us, necessitating difficult decisions about how we prioritise the remaining resources available to us. Currently we are focussing our efforts for new parking restrictions at locations where there is an injury accident record or our professional judgement suggests there is a safety concern which should be prioritised. New parking restrictions on the above road does not fall into that category and will therefore not be prioritised compared to other schemes on our safety programmes that are directly related to casualty reduction.

Successive cuts to local government funding combined with increasing pressure on social care budgets has severely limited the County Council's ability to carry out detailed reviews of every site reported to us, necessitating difficult decisions about how we prioritise the remaining resources available to us. However, as mentioned, with no parking related treatable collisions reported at this location we cannot justify considering new parking restrictions at this time.
