

HOLMSLEY BRIDGE REPLACEMENT July 2021



We would like to take this opportunity to introduce Knights Brown and advise you we are the principal contractor responsible for the construction of the Holmsley Rail Bridge replacement. Maintenance to strengthen and increase the lifespan of the structure has been ongoing, however the structure is now deemed uneconomical to repair. As such, the only safe and viable solution is a replacement. The new single span bridge, which will be built alongside the original, will ensure safer travel for all road users through the New Forest on this important route. The works will be complete by late June 2022.

UPCOMING WORKS

As we prepare to get work underway next month, we'd like to give you visibility of our schedule and the traffic management arrangements, which are as follows:

Monday 16 August 2021

We will mobilise to our site compound, which will be installed in the Osmonds Bushes car park comprising offices and welfare facilities. These will be powered by a super silenced generator until we're able to connect directly to a cabled power supply to be installed by SSE. This will keep noise to a minimum and reduce carbon emissions compared to a traditional diesel generator setup. Once the compound is established we will secure the permanent works area with temporary fencing and locate all underground services. We will be installing water pipe ducting underneath the carriageway and are obliged to remove five non-native trees. This will require singles lane closures of the A35 between 17 – 18 August 2021. These will be managed under two way traffic lights to keep our team safe.

Wednesday 1 September 2021

After the bank holiday weekend, we will take possession of the highway and the bridge replacement scheme will get underway.

The traffic management arrangements up to the end of this year will be phased as follows:

- 1 September 17 December 2021: Single lane closure on the A35 managed with two way lights
- 1 September 16 October 2021: Full road closure of C10 Station Road
- 1 November 17 December 2021: Full road closure of C10 Station Road

However, please note cycle route NCN2 will be closed for the duration of the works. A temporary diversion route is being prepared in collaboration with SUSTRANS and New Forest National Park Authority.

Likewise, the undesignated bridleway running under the north span of the bridge will also be closed.
